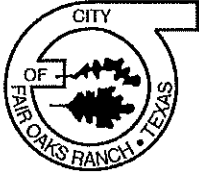

INTRODUCTION/BACKGROUND:

Texas Election Code Chapter 32 and City Charter Section 4.02 states the City Council shall appoint the election judges and other election officials for city elections. As such, City Council passed and approved Resolution 2018-01 stating “the City Secretary shall serve as the election judge for the May 5, 2018 General Election of the City of Fair Oaks Ranch”.

This agenda item today amends the Resolution by appointing an alternate judge in case the judge is unable to serve on Election Day. Due to experience and continued education in Election procedures, it is recommended the Assistant City Manager serve as the alternate election judge. The Assistant City Manager has served as an election judge in the past.

RESOLUTION 2018-07
**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIR OAKS RANCH,
TEXAS, AMENDING RESOLUTION 2018-01 TO APPOINT AN ALTERNATE JUDGE
FOR THE GENERAL ELECTION TO BE HELD ON MAY 05, 2018**

WHEREAS, on January 18, 2018, the Fair Oaks Ranch City Council passed and approved Resolution 2018-01 ordering a general election for the City of Fair Oaks Ranch to be held on May 5, 2018; and,

WHEREAS, pursuant to Section 32.005 of the Texas Election Code and Section 4.02 of the City Charter, the City Council shall appoint the election judges and other election officials for an election ordered by the City Council; and,

WHEREAS, the City Council of the City of Fair Oaks Ranch finds Resolution 2018-01 did not provide for the appointment of an alternate judge and as such, determines the appointment of an alternate judge for the May 5, 2018 general election is warranted.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIR OAKS RANCH, TEXAS:

1. Effective May 3, 2018, Section 8 of Resolution 2018-01 is hereby amended as follows and all conflicting provisions are repealed or replaced:

The City Secretary shall serve as the judge and *the Assistant City Manager shall serve as the alternate judge* of the May 05, 2018 General Election of the City of Fair Oaks Ranch as required and authorized by law.
