A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIR OAKS RANCH TEXAS CANVASS OF RETURNS AND DECLARATION OF RESULTS OF THE GENERAL ELECTION HELD MAY 6, 2023 IN THE CITY OF FAIR OAKS RANCH, TEXAS

**WHEREAS**, on the 12th day of May 2023, at a special meeting of the City Council of the City of Fair Oaks Ranch, Texas, with at least two council members being present, the meeting was called to order to open, examine, and canvass the official returns of the general election held in the City on the above-mentioned date, for the election of Council Member Place 2, and Council Member Place 6.
