MINUTES

OPEN MEETING

1. Roll Call - Declaration of a Quorum

With a quorum present, the meeting was called to order at 6:30 PM.

2. Pledge of Allegiance – The Pledge of Allegiance was led by Mayor Maxton.

CITIZENS and GUEST FORUM

3. Citizens to be heard – Citizen Christine Graham spoke in appreciation of the police department for their help with monitoring feral hogs spotted near school bus stops in the Setterfeld community.

PRESENTATIONS

- 4. Joanna Merrill, IPMA-SCP, Director of Human Resources & Communications introduced to Council new employees: Jimmy Washer Maintenance Technician (not present), James Ramirez Maintenance Technician, Harley Butler Police Officer, Grant Watanabe Director of Public Works & Engineering Services.

10. Consideration and possible action approving the first reading of an Ordinance amending the Code of Ordinances, Chapter 1, General Provisions, Article 1.05 Records Management.

Christina Picioccio, City Secretary, provided an overview of the history and goals for future direction of the city's records management plan. Council voiced interest in modifying state schedules in certain records under council purview: agendas, agenda packets and recordings. Council requested that City Secretary provide at a future meeting, estimation of storage capacity to help determine these timelines.

Joanna Merrill, IPMA-SCP, Director of Human Resources & Communications, provided an update on options and pricing for multi-platform public meeting options after which she was provided direction by Council to pursue a basic option that could be built upon in the future if necessary.

City Manager, Tobin E. Maples, announced that the household hazard waste event is scheduled for September 18, 2021 at the Cibolo Creek Church, the bulk pickup project is ongoing in the City, and the street maintenance program is scheduled to begin September 9, 2021. Mr. Maples also informed Council of repairs to City Hall and the Public Safety Building.

 - a. Council Member Elizondo asked a future consideration item for a workgroup that would define a guideline to include a definition of transparency and set the standard performance for the organization.
 - b. Mayor Maxton requested that a discussion regarding feral hogs be placed on a future agenda.
