1. Prior to having service(s) connected, provide a copy of applicants' non-expired drivers' license along with this Completed Water / Wastewater Service Application to the Utilities office in person, by mail, fax, or email.
2. Application fee of \$30.00 will be included on the first bill.
3. Payment is due every month for all services as billed in accordance with the rates, rules and regulations set by City ordinance. **Due date is the 25th of Each Month.**
4. Failure to receive a bill does not relieve applicant their obligation for payment, or the consequences of non-payment. If a mailed bill is not received, the applicant is responsible to contact the Office for total amount due.
5. Monthly automatic drafts from applicant's bank account are available. Contact the Utilities office for more information.
6. Accounts can only be closed by applicant(s) whose name appears on this application and a completed Disconnect Request Form.
7. Fair Oaks Ranch will not disclose customer information unless the customer elects to make the information public. Request for Disclosure of Information Forms are available at City Hall and on the website.
8. Irrigation of landscaped areas with hose-end sprinklers or an automatic irrigation system is allowed once a week between midnight to 10 a.m. and 8 p.m. to midnight on the authorized watering day according to applicant's street address ending in:  
**0 or 1 - Monday   2 or 3 - Tuesday   4 or 5 - Wednesday   6 or 7 - Thursday   8 or 9 - Friday**

**Please Note:** If a customer vacates rental premises with a utility past due balance, the property owner (landlord) shall become the customer of record and be responsible for the past due balance before service can be reconnected or transferred to a new customer account. As such, City reserves the right to apprise the listed Landlord of any past due amounts as they accrue.

**Please Note:** It shall be unlawful for any person, firm, or other entity to damage, molest, move, connect to disconnect from, bypass or remove or in any other way tamper with water or sewer mains, lines, or equipment. If any damage results from any of these or other illegal actions, the owner shall be immediately responsible financially to Fair Oaks Ranch Utilities for repair and/or replacement to the original state. Any repair of accidental damage to these facilities will also be billed to the owner.

## Definitions

### Water Fees:

- Surface water: the cost of water distributed by the Guadalupe-Blanco River calculated in dollars per one-thousand gallons' times 6,000 gallons minimum.
- Texas commission of Environmental Quality (TCEQ): The annual TCEQ water fee divided by number of service connections the month payment is made to TCEQ.
- Trinity Glen Rose Groundwater Conservation District: The ratio of total monthly water produced divided by total monthly water billed times the TGRGCD prevailing rate per thousand gallons.
- Debt Service: The water portion of the total bond payment (including principal and interest) in the upcoming fiscal year divided by number of service connections as determined on June 1st.
- Capital Reserve: The budget goal divided by number of service connections as determined on June 1st.

### Wastewater Rates:

- Service Availability: Average of three previous fiscal year actual wastewater expenditures less debt interest divided by number of service connections as determined on June 1st.

### Wastewater Fees:

- Texas Commission on Environmental Quality (TCEQ): The annual TCEQ wastewater fee divided by number of service connections the month payment is made to TCEQ.
- Debt Service: The wastewater portion of the total bond payment (including principal and interest) in upcoming fiscal year divided by number of service connections as determined on June 1st.
- Capital Reserve: The budget goal divided by number of service connections as determined on June 1st.
